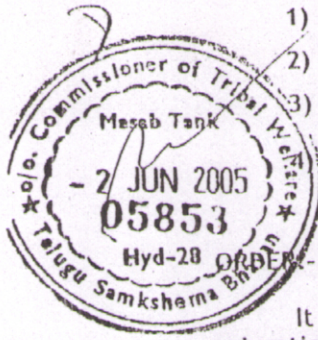

It has been proposed to start, under the guidance of Sri Ch. Ramayya-noted educationist, Schools of Excellence by Department of Tribal Welfare, to provide necessary academic inputs to the S.T students to enable them to compete successfully for admissions into IITs, NIT, IIIT and Medical Colleges etc.

The Member Secretary, Gurukulam in the reference 3rd read above has submitted a proposal. Government after careful consideration hereby sanction three Institutions of Excellence for providing specialized coaching to meritorious ST students in the ITDAs of Parvathipuram, Bhadrachalam and Srisaillam for the academic year 2005 - 06

1. The three Institutions of Excellence will be started for the academic year 2005-06 at Bhadrachalam(Khammam Dist.), Srisaillam (Kurnool Dist.) in addition to Parvathipuram(Vizianagaram Dist.) with the jurisdiction as follows:

Sl. No	Name of the School of Excellence	ITDA	Catchment Districts
1.	Parvathipuram	Parvathipuram	Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari and Krishna
2.	Bhadrachalam	Bhadrachalam	Khammam, Warangal, Adilabad, Nizamabad, Karimnagar, Mahaboobnagar, Nalgonda, Hyderabad, Medak, Rangareddy
3.	Srisaillam	Srisaillam	Kurnool, Guntur, Prakasham, Nellore, Chittoor, Kadapa, Anantapur

2. Each school with English medium of instruction will draw the best students through a test for admission into 8th, 9th, 10th classes for academic year 2005-06. Inter I & II year will be started in subsequent years.
3. Each school will have (3) sections in each class (VIIIth to Xth classes) with each section having (30) students, of whom a minimum of 30% will be girls. Seats will be reserved for various tribal groups from each district (comprising the catchment area of the institution) in proportion to the population of those tribal groups in those districts.

4. Incentives shall be given to the teachers selected as follows:

- a. The incentive shall be given to the Principal and Teachers @ Rs. 1665/- per month and Rs. 1600 per month respectively as they have to handle additional work load by way of assignment, correction/valuation and extra classes.
- b. **Additional Incentives:** In order to motivate the teachers to strive for excellence, the following additional incentives shall be apportioned among Principal and Teaching staff as per a formula to be worked out by Tribal Welfare department in consultation with concerned.

(i) INCENTIVES FOR XTH CLASS RESULTS:

- c. An amount of Rs.20000/- will be provided as incentive to the non-teaching staff in terms of G.O. first read above.
 - d. The transfer rules will not apply to the teachers deputed / selected to these schools.
 - e. The children of the teachers selected will be permitted to attend in the classes only subject to obtaining a overall minimum level of 50% performance in their qualifying class
 - f. The selected teachers shall have to work with total commitment and dedication. Continuation of deputation shall be based strictly on performance.
5. To attract the best talent, interested teachers / Junior Lecturers from Ashram Schools, Govt. Schools / Colleges, Residential schools / Colleges, Aided Schools / Junior Colleges & retired teachers will be called for a preliminary screening at district level or ITDA level through a transparent peer group assessment. The short listed teachers will be further screened and final selection made at State level by Sri Ch. Ramayya & subject experts.
6. The incentives announced above shall be extended to any other Gurukulam School or Junior College which secures results on the same lines as at para 4(b) above.

7. The budget will be met from Pre-matric Scholarship scheme and the existing posts redeployed including by conversion, wherever required.
8. The Commissioner, Tribal Welfare / Member Secretary, Gurukulam shall ensure the institutions commence from this academic year duly providing necessary amenities and ensure completion of other procedures & formalities etc.
9. The Commissioner, Tribal Welfare / Member Secretary, Gurukulam are requested to take action accordingly.
10. This order issues with concurrence of Finance Dept. vide their Secretary (FP) Peshi, No. 131/54-TW, dated: 16-05-05.
