ORDER:

In the reference 1st read above, orders were issued that, women CRTs working in Gurukulam institutions who have completed one year of service are hereby permitted to avail maternity leave for 45 days with remuneration with prospective effect.

In the circular 2nd read above, the same was extended to the Guest Teachers/ Lecturers, working in Gurukulam Institutions. Further implemented to the Women CRTs (Time Scale), Minimum scales has been extended, vide reference 3rd read above.

In pursuance of the orders vide 4th read above, the existing maternity leave of 45 days is hereby enhanced to 60 days to women CRTs, Guest Teachers/ Lecturers and Women Contract Non Teaching staff working in Gurukulam Institutions henceforth.

In the G.O., 5th read above, the Maternity Leave ordered for 180 days is hereby extended to the regular female employees of Gurukulam including the Minimum Time Scale CRTs, working in the institutions who are being paid the minimum pay + D.A of TGT scale subject to the conditions stipulated in the G.O. are fulfilled by the employees.

All the Principals of APTWRS/ RJCs of Gurukulam are requested to take necessary action, for implementation of the above orders, without any deviation.
